Approval of Meeting Minutes

Officer Elections

Board held discussion on 2019/2020 open officer positions. Positions discussed Board Treasurer, Board Secretary, Board Vice President.

Dr. Nofal volunteered to serve as Board Treasurer.

Dr. Baker volunteered to serve as Board Vice President.

Mrs. Batrony volunteered to serve as Board Vice President.

Mrs. Woods volunteered to serve as Board Secretary.

Dr. Baker stated he would like to withdraw his interest in Board Vice President, as Mrs. Batrony shared interest in serving in the position.

Motion by Board President, Dr. Ahmed Rezk to nominate the above members to the vacant positions. Second by Mr. Albibi . Board vote all in favor to elect the above Board Members into the elected positions for the 2019/2020 school year.

A discussion was held regarding terms and elections with the new bylaws. It was determined that board elections would occur at the end of each school year. The seats held by Ms. Kelly, Dr. Nofal and Ms. Batrony would be re-elected in the 2021/22 school year, the seat held by Dr. Garman would be re-elected in the 2020/21 school year. The seats held by Ms. Woods and Mr. Steindbrecher would be re-elected in the 2019/20 school year. The election cycle for the remaining three seats would be determined by January 2020.

2019/2020 Administrator Evaluation System & Principal's Evaluation Committee

Mrs. Amber Perryman provided the Board with the Principal's Report outlining student enrollment per grade level comparisons, academic programs, extracurricular enrollment numbers, and facility update.

Financial Report

Dr. Jaber presented the proposed 2019/2020 Budget for Board review, discussion, and approval. Motion by Mr. Rezk to approve 2019/2020 Budget. Seconded by Dr. Nofal. Board vote all in favor to approve.
